16-19 July 2015 - Special Academic Session on the Safety of Journalists – Berlin, Germany

Organized on the occasion of the 10th Global Communication Association (GCA) Conference, this Special Session is the first in a series of dedicated workshops aiming to strengthen cooperation with academia in line with the UN Plan of Action on the Safety of Journalists and the Issue of Impunity, and to establish an academic research agenda on journalists' safety. Different aspects of journalists' safety and issue of impunity will be discussed on this occasion.

As the UN agency with a specific mandate to defend freedom of expression and press freedom, UNESCO actively promotes the safety of journalists and those who produce journalism. UNESCO has championed the UN Plan of Action on the Safety of Journalists and the Issue of Impunity which is the first concerted effort

16-17 July 2015 - 9th Session of the Intergovernmental Bioethics Committee (IGBC), UNESCO Headquarters, Paris

This 9th session will be mainly devoted to examining the work done by the International Bioethics Committee of UNESCO (IBC) in the 2014-2015 biennium: the elaboration of the principle of the sharing of benefits as set out in Article 15 of the Universal Declaration on Bioethics and Human Rights (2005), and the update of the IBC's reflection on the human genome and human rights. IGBC Member States will also be invited to discuss critical bioethical issues that could be suggested to the IBC for consideration when defining its Work Programme for 2016-2017.

The IGBC was created in 1998, comprising 36 Member States elected by the General Conference of UNESCO, whose representatives meet at least once every two years to examine the advice and recommendations of the IBC.

12 August 2015 – International Youth Day

This Day will bring youth issues to the attention of the international community and celebrate the potential of youth as partners in today's global society.

12 August was first designated International Youth Day by the UN General Assembly in 1999, and serves as an annual celebration of the role of young women and men as essential partners in change, and an opportunity to raise awareness of challenges and problems facing the world's youth.

Thematic discussions and information campaigns will take place across the world, to engage both Member States and the general public to understand the needs of young people, to implement policies to help them overcome the challenges they face, and to encourage young people into the decision-making process. These objectives of the International Youth Day 2015 will also be addressed during the 9th UNESCO Youth Forum, taking place in the autumn of 2015. I will provide you with information on the Youth Forum shortly.

Within this framework, I encourage our NGO partners to organize activities closely involving youth. Please feel free to send us information on any activity you intend to coordinate and we shall publish it on our website www.unesco.int.
