Dear Partners,

The 191<sup>st</sup> session of the Executive Board ended a few days ago and was rich in discussions of direct interest to NGOs and our partnership. There was a general appreciation for the progress made in reinvigorating cooperation with NGOs, widening the scope of this partnership, and rendering such partnership more focused and action-oriented.

For the first time ever, Mr Patrick Gallaud, Chairperson of the NGO-UNESCO Liaison Committee, addressed the Executive Board, at a plenary meeting, on behalf of the community of NGOs, official partners of UNESCO. He presented the conclusions of the International Conference of NGOs that was held in December 2012 as well as the new strategic orientations for the collective action of NGOs.

The Committee on Non-Governmental Partners (NGP), which met on 11 April, held a thematic debate on UNESCO's cooperation with NGOs in the field of water. The discussion highlighted how this cooperation is key in areas such as water education and water management, in reducing water hazards (droughts and floods), in promoting scientific research and dissemination of information, in setting policies at all level and in generating political will in all fields of water.

I am also pleased to inform you that the Executive Board decided to admit two NGOs as official partners with associate status: the Observatory of Cultural Policies in Africa (OCPA) (Mozambique) and B'nai B'rith International (USA). The Board also took note of the admission of seven new NGOs and two Foundations, which joined our network recently:

#### **Open Access Policy concerning UNESCO publications**

On 26 April 2013, the Executive Board of UNESCO adopted a new Open Access Policy for UNESCO's publications, making UNESCO the first UN agency to adopt such a Policy for its publications.

The intention is that all content (e.g. print, audio, video and multimedia) shall be made available for free online access, allowing any user in the world to freely read, download, save, copy, print, reuse, adapt and translate the full text of UNESCO's publications. By progressively releasing all publications with an open license, we shall provide governments, educational and research institutions, teachers and learners with a powerful opportunity to improve the quality of education as well as facilitate policy dialogue, knowledge sharing and capacity building, in particular in developing countries.

### 10 June 2013 – Conference on the theme 'From the Double Helix through the Human Genome to the Human Variome', UNESCO Headquarters, Paris

UNESCO is organizing this event in collaboration with the Human Variome Project Consortium to celebrate the 60<sup>th</sup> anniversary of the discovery of the double helix of DNA as well as the tenth anniversary of the completion of the Human Genome Project and the tenth anniversary of the adoption of the UNESCO International Declaration on Human Genetic Data and Human Rights.

UNESCO has joined forces with the Human Variome Project, the successor to the Human Genome Project. It aims to identify and collect information on human genetic variation and mutations as a basis to advance scientific understanding of the role of genetics in human disease.

To accompany the conference, an exhibition will be organized covering the history of genetics and the main topics covered in the conference with a series of images, explanatory texts and timeline representing the main milestones in the history of genetics.

# 19-21 June 2013 - 20<sup>th</sup> session of the International Bioethics Committee (IBC), Seoul, Republic of Korea

The 20<sup>th</sup> session of this Committee will be held at the kind invitation of the Government of the Republic of Korea.

During this session, IBC will continue its work on the principle of non-discrimination and non-stigmatization as set forth in Article 11 of the UNESCO Universal Declaration on Bioethics and Human Rights (2005). This principle will be used to transversally analyze new risks and responsibilities arising from progress in different areas of medicine, life sciences and associated technology. The session will also be an occasion for IBC to reflect on its work programme for 2014-2015, on bioethical concerns within the Asia and Pacific region, and on the role of bioethics in the post-2015 development agenda.

IBC was created in 1993. It is a body of 36 independent experts that follows progress in the life science and its applications in order to ensure respect for human dignity and freedom. This is the only international forum of its kind in the field of bioethics.
