## Agreement

between the

World Federation of Engineering Organisations (WFEO)

and

The International Centre for Engineering Education (ICEE)

On

Co-operation in Engineering Education

Paris, 7, March 2018

## **1. PURPOSE**

The purpose of this Agreement is to promote cooperation in and joint promotion of activities designed to provide independent and internationally recognised actions on engineering education. The co-ordinated efforts of the members of WFEO and ICEE will be undertaken through agreed policies and programs.

## **2. ACKNOWLEDGEMENTS**

WFEO and ICEE acknowledge that:

WFEO established in 1968, is the peak body for national and regional professional engineering institutions

and

ICEE is a Category II centre of UNESCO, established under the auspices of UNESCO on 6 June 2016. ICEE is committed to building itself into an equal, inclusive, developmental and win-win engineering education community for the promotion of quality and equity in engineering education amongst the countries of the world.

Both organisations agree to cooperate with each other to advance the contribution of the engineering profession for the benefit of peoples throughout the world.

## **3. JOINT ACTIVITIES**

The organisations may enter into joint projects and events such as projects, conferences and forums, as agreed from time to time.

The organisations will also enter into joint activities devoted to promote and support engineering education, preserving and sustaining the environment, improving the engineering, sciences and technology awareness in the general public and improving the image of the engineering and technological sciences generally.

The organisations will seek opportunities to cooperate in the preparation of policy statements in their shared areas of expertise which may be made available to national and international organisations to inform them and others of important issues relevant to humanity.

## **4. INVITATIONS TO CONFERENCES, EVENTS AND TECHNICAL MEETINGS**

Schedules for conferences and major events will be exchanged between the organisations.

## **5. JOINT MEETINGS**

Each organisation agrees to invite the other to send an observer to major meetings: the ICEE major meetings and forums and and WFEO General Assembly and to welcome participation in associated conferences or forums held in conjunction with those meetings.

## **6. REVIEW AMENDMENT AND TERMINATION**

The term of this Agreement will be for an initial duration of four (4) years from the date of signature.

Either organisation may terminate its obligations under this agreement by three months in notice to the other party.

Amendments to the Agreement may be proposed at any time.


This Agreement and any amendments thereto will come into force only after ratification of the governing bodies of each organisation.
