## Important reminder concerning the use of the name, acronym, logo and Internet domain names of UNESCO and the patronage

As you know, the use of the name and logo of UNESCO are strictly regulated by the *Directives concerning the use of the name, acronym, logo and Internet domain names of UNESCO*.

I wish to emphasize that their use is not automatically authorized for NGOs. Please find attached, guidelines applicable to NGOs in this field. I urge you to refer to the relevant useful clarifications contained in this document.

As distinct and autonomous entities, NGOs in official partnerships with UNESCO are **not** authorized to use the UNESCO name, acronym, or logo on a permanent basis on their branding and communication materials or on their websites.

Instead, depending on the nature of its partnership with UNESCO, an NGO may use one of the following standard sentences, next to its own logo, for purpose of information:

- [NGO] in official partnership with UNESCO
- [NGO], official partner of UNESCO (associate status) or (consultative status)

NGOs, however, may request UNESCO's authorization to use the name, acronym and logo of UNESCO on a temporary basis in connection with:

- patronage from UNESCO for events that NGOs organize;
- implementation of projects in cooperation with or with the support of UNESCO.

In this regard, I also wish to recall that patronage is a form of UNESCO's support for those activities which are entirely organized by other entities. UNESCO is not involved in any way in their organization, and is not responsible for them.

NGOs in official partnership with UNESCO can send their requests, which should be composed of the completed Patronage Request Form available on the dedicated website, and a brief covering letter addressed to the Director-General of UNESCO, directly to the Office of the Director-General. The evaluation process at UNESCO Secretariat takes between six and eight weeks.

If patronage is granted by the Director-General, the activity organisers will be given the permission to use the UNESCO logo accompanied by the mention "Under the patronage of UNESCO" on their communication materials for the activities.

# 29 June 2017 - Multi-Stakeholder Consultation on Strengthening the UN Plan of Action on the Safety of Journalists and the Issue of Impunity, Geneva, Switzerland

Organized by UNESCO and the Office of the United Nations High Commissioner for Human Rights, this meeting will bring together key stakeholders to take stock of developments in the area of safety of journalists and the issue of impunity, within the context of the first five years of implementation of the UN Plan of Action on the Safety of Journalists and the Issue of Impunity.

Member States, intergovernmental organizations, non-governmental organizations, members of academia and media and professional associations will gather to assess their achievements, consider the future and share best practices.

The issue of safety of journalists and ending impunity for human rights violations committed against them, in both conflict and non-conflict situations, is gaining momentum within the framework of the Sustainable Development Goals (SDG) that make up the 2030 Agenda for Sustainable Development. In particular, Goal 16 highlights the protection of fundamental freedoms and public access to information. Journalist safety and ending impunity for human rights violations are critical components of achieving this goal.

Member States, media, academics and civil society are invited to send their contributions ahead of the meeting on protecting journalists. Their contributions will be an essential resource in preparing the draft outcome document for the Multi-Stakeholder Consultation.

## 2-12 July 2017 - 41<sup>st</sup> session of the World Heritage Committee, Kraków, Poland

Organized by UNESCO with the Republic of Poland, the 41<sup>st</sup> session of the Committee will meet in Kraków (Poland), whose old town was among the first 12 sites inscribed on the World Heritage List.

This session will notably consider requests for the inscription of new sites on UNESCO's World Heritage List, and examine the state of conservation of sites already inscribed on the List as well as many other issues concerning the implementation of the World Heritage Convention.

As part of the 41<sup>st</sup> session of the World Heritage Committee and in the framework of the UNESCO World Heritage Education Programme, the Polish National Commission for UNESCO and the International Cultural Centre in Krakow are holding Heritage Youth Forum 2017 "Memory: Lost and Recovered Heritage" from 25 June to 4 July 2017. Young representatives, aged from 22 to 32, from 35 countries, will have the opportunity to exchange ideas, contribute to the discussions and immerse themselves in topics within the scope of lost and recovered heritage.

NGOs interested in assisting as an observer should send a formal request to the Secretariat of the World Heritage Convention in advance.

### 6 July 2017 - Internet Governance Forum Conference 2017, Nairobi, Kenya

Organized together with the Kenya ICT Action Network (KICTANET), themed on "Shape your Digital Future!", this Conference aims to serve as a platform for policy dialogue on issues of Internet governance in Kenya.

During the conference, the following topics will be discussed: Internet and elections; surveillance and human rights online; policies enabling access and digital literacy in the age of e-government; cyber-security; review of Kenya's ICT policy; universal service fund; IFMIS and its challenges among others. These topics are important in light of the August general election, and the fact that technology will be deployed at a level that has not happened in the previous general elections.

The Forum is a unique platform for all national stakeholders to openly exchange perspectives and concerns on key issues that may affect the future of the Internet for millions of Kenyans. This year's forum will attract participation of stakeholders from government, private sector, technical community, academia and civil society to discuss Internet governance issues on an equal footing through an open and inclusive process.

I encourage you to mobilize your national branches in Kenya for this important issue.
