- 2.2.3 print, publish, sell, lend or distribute proceedings or reports of the institution or any papers, documents or communications in engineering science and its applications;
- 2.2.4 make grants of money, books, apparatus, or otherwise, for the purpose of promoting innovation, invention, or research in engineering, or promoting engineering education;
- 2.2.5 establish a Benevolent Fund to be constituted and applied in accordance with these Rules;
- 2.2.6 Establish a Council of the Institution which shall govern and control the Institution, its property and affairs, subject to the provision of these Rules.

We directly or indirectly represent 1100 engineers.

If declared, our organisation commits to celebrating World Engineering Day with a wide range of activities that promote the role of engineering for climate change action and sustainability as urgent action is needed in these areas. Such celebrations will improve community recognition of the importance of engineering to society and the economy.

The activities to celebrate World Engineering Day is expected to encourage young people, girls and boys, to raise the number of people studying science and mathematics, increasing the intake of engineers into universities. This is critical for the sustainable development of our country.

We anticipate that our activities will reach and have an impact on 1.3 million people in our country/region.
