#### 4. Report by Chair

WURC has made great progress with the UN based on Eng. Jorge Spitalnik laying the foundation as the WFEO representative at the UN Commission on Sustainable Development in the last decade and thereon at the Rio+20 Conference that led to the creation of the High Level Political Forum (HLPF). WFEO relations with the UN and intergovernmental bodies were substantiated by his initiative of creating WURC. WURC has placed WFEO on the UN Stage and WURC is doing great work with no WFEO funding

WFEO participates through WURC in IAEA, UNIDO, UNESCO, UNFCCC The Chair serves on the HLPF Steering Committee, Dr. Bill Colglaizer (former Science and Technology Advisor to the US Secretary of State) - who co-chairs the UN Group to Support Technology Facilitation Platform for the UN SDGs - is a member of the US subcommittee of WURC.— The Chair works with the UN NGO Major Group of Scientific and Technological Communities as WFEO representative. In addition, Donovan Guttierez - who is a member of the UN Major Group for Children and Youth - is also a member of the WFEO Young Engineers and Future Leaders Committee and contributes with the WFEO representation. Andy Reynolds, formerly with US State Dept and former Chair of CSTD UNCTAD, is a member of the US Subcommittee of WURC and is helpful in promoting WFEO.

A WiE member, Stacey M. DelVecchio, attended and prepared a report for the 60th Commission on the Status of Women (CSW60, ref.: www.unwomen.org/en/csw/csw60-2016/) held at the UN in May 2016; the report will be available on the website.

Jorge Spitalnik and Chair represented WFEO at this year's UN IAEA meetings in Vienna, C. Remec represented WFEO at UNIDO meetings and D. Danyluk represented WFEO at UNFCCC meetings.

Van Veelen (CECB) discussed a financial issue in the institutionalization of the African-version of the HLPF under the UN Economic Commission in Africa. He indicated there may be a solution working with ICSU.

WFEO representatives to UN meetings are requested to prepare a report on the meeting ASAP to share any information with WFEO members and post on the WFEO website.

#### 5. Reports by attendees and STCs

 A STC cannot be expected to work on all 17 SDGs and the 169 targets. WURC welcomes all input for the UN from the STCs.

#### 6. COP22 report

- The WFEO delegations to the UNFCCC COP22 (Moroccan WFEO members and Engr. Daniel Favrat, the former chair of CEE) attended the COP22 in November 2016, at LET US ASK DANIELMarrakech, Morocco. A report on the meeting was prepared by ZIZZO Strategy for the COP22. The report shows the implementation of COP for climate change. Note that the ZIZZO Strategy is a strategic consultancy focused on climate change, resiliency, and the move toward the low-carbon economy (ref.: zizzostrategy.com/category/unfccc/).
- WFEO will have а representative (delegation), Ken Durrands, jennydurrands100@hotmail.com) DARREL SHOULD ANSWER THIS QUESTIONto the UNFCCC SUBSTA meetings and the UNFCCC COP23 in Bonn, Germany in May and November 2017, where the Fiji representative becomes a co-chair. Details on registration process will be circulated when it is available. CEE has participated in past COP meetings because of its work on climate change. The CEE secretariat will work with Darrel Danyluk for COP23.

WURC is the intermediary between all STCs and UN organizations such as UNFCCC and public international bodies to promote collaboration and establish relationships.

#### .9. New Business

Activities planned for 2017 and 2018. Efforts are underway to hold side events at the UN High Political Forums in the June /July time frames in 2017 and 2018. The 2017 HLPF will be held 10-19 July 2017. The 2017 side event will be devoted to SDG 9 and the 2018 side event would be devoted to SDG 11. Coincidentally, the Innovative Technologies STC is focusing on SDG9 and SDG 11. Details will be released as they are developed.

Contents of the 2016 March meeting in Paris were discussed. What does WFEO contribute to the UN webinars (a seminar via the internet) and meetings in New York through contribution to the UN's SDGs for WFEO visibility across the world?

#### 8. Questions to be distributed to STCs

WURC will recommend to the Executive Council that a questionnaire be developed to determine which if any SDG each STC is pursuing and a series of question to determine how the STC input can be formed to support the side events and the SDGs .Thus, the STC activities on SDGs could be highlighted at the proposed 2017 and 2018 WFEO side events.
